The Department of Radiation Oncology celebrated its Platinum Jubilee from January 9 to January 11, 2014. A conference on 'Leadership in Cancer Care- Evidence with Relevance' was held to mark this important milestone of 75 years of the Department. The Department was established by Dr. Ida Belle Scudder- affectionately called Dr. Ida B.- in 1939. The first patient, a young boy, was treated by Dr. Ida B. with a Deep X-ray Unit. Since then, the Department has grown in stature and is

now recognised as one of the leading radiation therapy centres in the country.

Dear Friends

The excitement that accompanies the acquisition of anything new is unique. A new toy for a child, a new set of clothes for a teenager, a new cell phone for a college student, a new laptop for a young professional or a new car for a family evokes the same kind of joy as when one moves into a new home. Its much more with a newly married couple or when a new born child is added to the family. This joy is independent of whether the new object is a gift, given or bought. The pleasure associated with unfolding the wrapper of a gift after a birthday party can be watched in our children. Discovering the newness of something is very unique.

WHAT DO YOU THINK?

Thanks to John Gault for this article to make us think, take a look from another direction, reconsider, seek knowledge from elsewhere. Thanks also to our God who gives us faith and the freedom to think.

WHY A HUMANIST SHOULD SUPPORT THE CHRISTIAN MEDICAL COLLEGE,VELLORE.

Religion in general, and Christianity in particular, has a record of cruelty and persecution. On the other hand, it also has a strong record of care for the ill, practical concern for the poor, support of music, and the preservation of knowledge. Christianity, at least, has outgrown its cruelty and persecution, while the other aspects continue.

Humanists are fond of pointing to the sorry record of Christianity, but have not been strong themselves in supporting benefits to humanity. This is now changing. A number of non-government organisations helping the disadvantaged overseas have a secular basis.

In India virtually everybody is, at least nominally, a religious person. The decline of religion, as seen in the West, has hardly touched the country. Secular humanism is virtually non-existent. Therefore, if one wishes to support an organisation that serves humanity – whether educational, medical, or social service, the vast majority will have a religious basis. This has been the case with medical missions since their inception. Their prime basis has been that of helping the sick, rather than proselytising.

This is not to say that preaching the Gospel did not take place within these institutions. Those who work in them derive their work from their Christian faith, and wish to make that evident. However, I have never heard or read of any complaint by patients or politicians. The medical treatment provided has never been dependent, or in any way related to the professed religion of the patient.

One would have to acknowledge that strict Catholic views on matters of reproduction would, in India as in Australia, be incompatible with views on such matters held outside the Catholic Church. A humanist would therefore not wish to support an organisation with such restrictive views.

It can be said that whatever the religious or non-religious views a person holds, they could freely support an organisation such as the Christian Medical College Vellore.

CMC VELLORE AND MEN!

The Christian Medical College for the training of women was founded in 1900 through the vision and practicality of Dr. Ida Sophia Scudder. Nevertheless, she had the foresight to recognise the need for inclusion of male students. Despite feminist donors in the USA withdrawing their support, Dr. Scudder held firm. In 1943, the year in which men were admitted to the Christian Medical College Vellore South India, Professor Edward Gault was appointed the first Professor of Pathology and Dean of the Men's Hostel.

Two Melbourne men's names are inscribed on buildings at CMC Vellore: The Norman Institute of Pathology and the Norman Auditorium; the Gault Library (actually in honour of both Edward and Edna Gault) and Edward Gault Drive. The first Norman post graduate scholarship in Australia was awarded to Dr. L.B.M Joseph who studied with Weary Dunlop and Sir Benjamin Rank, going on to become a CMC Vellore Director. This year the Howard Norman Scholarship was awarded to a Diploma of Nursing student. Typically Diploma students come from poor families in villages to which villages they return to give service after graduation, a path not usually taken by Bachelor of Nursing graduates.
